

Terms of Hire – Innlandet Bilutleie



1. Both the driver and the hirer must be 19 years and have held a valid driver's license for one year.
2. The lessor must receive a copy of the driver's license of all drivers of the car and add the additional drivers on the contract.
3. The vehicle / rental item should not be loaded or used to practice driving, road racing, recreation, competition, or transportation of animals, goods and other uses which emit odours, stains or other damage. It is not allowed to smoke in the car. This also applies to e-cigarettes.
4. Security in the form of reservation on card must be provided for estimated rent, day/km, CDW, fuel, toll crossings and other fees and costs. Minimum card reservation is estimated rent plus NOK 1,000. There are minimum rates for card reservations per category. The lessor has the right to deduct the card reservation from the total rent as well as other costs mentioned above and/or any recourse claims cf. Point 6. Amounts are reserved on a VISA or MC. After the rent has been settled by the lessor, the bank can use up to 5 banking days to release the rest of the card reservation.
5. The hirer shall be liable for all damage which occurs during the hire period even if such damage has been caused by other parties than the hirer. However, the hirer's liability shall for each damage be limited to the excess fixed unless the hirer/user of the vehicle has shown gross negligence. In the event of gross negligence and if, because of such negligence, the lessor's insurance company refuses to cover the damage occurred or brings a recourse claim, the lessor shall correspondingly have a recourse claim against the hirer. The hirer's liability for payment of excess shall be reduced the extent to which the liability is covered by other parties than the lessor's insurance company, for example the tortfeasor's insurance company.
6. The hirer's responsibility for excess shall lapse if the hirer takes out excess cover upon the commencement of the Rental Agreement. The price for such cover varies from category to category and will be stated on the Rental Agreement. The hirer may not invoke such a cover if this is not applied to the Rental Agreement. Damage caused as a result of gross negligence, loss of keys, filling the wrong type of fuel, costs due to an empty fuel tank, misuse of the vehicle, driving with a flat tire, failing to follow height, width and length limitations during the rental. In all injury the hirer is obliged to contact the lessor and fill out standard damage report that is in the car. The excess cover does not apply if you damage other cars or property. By damaging other cars or property, the excess is still limited to 10.000 NOK on category A-K and 15.000 NOK on category M - 0.
7. The lessor is responsible for maintenance of the car. Hirer is obliged to ensure control and replenishment of oil and coolant least every 1000km, as well as control of air pressure of all wheels. Expenses for oil and coolant covered by the lessor with approved documentation. Fuel and washer fluid are not included in the rental.
8. The hire vehicle is delivered is with a full fuel tank and must also be returned with a full fuel tank. If the hire vehicle is not filled full of fuel, there will be a fee of 300 NOK for refuelling, plus the amount of fuel filled. Filling the car with the wrong type of fuel will result in liability.
9. During the hire period and until the vehicle has been returned to the lessor, the hirer shall be fully liable for the vehicle and the use thereof as if he/she were the owner, including for parking and traffic offences toll fees, etc. The hire vehicle shall be returned in the same condition in which the hirer took over the vehicle. The vehicle must empty of trash and not be in such a condition that the vehicle need more cleaning than a regular cleaning. Are there stains, trash, odours and other things that require further cleaning, such as cleansing of seats, extra vacuuming etc., a fee of 1500NOK will be added to the rental.
10. Before each rental, the lessor takes picture of the car exterior and interior for documenting damage to the rental vehicle. The lessor recommends the hirer to do the same.
11. If the lessor is demanded payment of parking fines, speeding fines, tolls (Not applicable Auto Pass), towing and other charges or fees, the hirer will be charged a fee of 200NOK in addition to the original fee.
12. In the case breakdown or damage, the lessor's emergency telephone 61 10 06 66 without delay to determine where help can be obtained. The hirer cannot without the lessor's consent, require or order repairs. Ordinary assistance for starting the vehicle, for example in connection with a flat battery is not considered repair. Theft, theft damage, fire, personal injury, damage to the animals shall immediately be reported to the lessor and police.
13. If the hirer needs a rescue vehicle for reasons such as: driving of the road, a punctured tire, flat battery, loss / locked key in car, misfuelling / out of fuel and other causes that has been caused by the hirer or some 3rd party member, the hirer must cover the costs of rescue.
14. If the vehicle cannot continue due to breakdown, compensation shall only be paid for further transportation to the destination by public transport such as trains and buses. The Lessor shall not be liable in any way whatsoever for expenses incurred for transportation except for the above. This exclusion of liability shall apply for loss of time, financial loss or any other loss caused by breakdown or any loss which may arise out of or in connection with the rental agreement. If the breakdown is due to damage for which the hirer himself is responsible, the compensation for further transportation shall lapse.
15. For longer trips than 300km from the office, the lessor must be informed about the destination. If the hirer will drive outside of Norway, this must be approved by the lessor and must be applied on the rental agreement. When driving outside of Scandinavia, all liability lies with the hirer. It is required that the hirer has membership in NAF to drive outside of Scandinavia.
16. The hirer is obligated to comply with the terms and conditions stated in this agreement. The hirer must return the vehicle on or before the specified date and time to the same location where it was rented. The hirer agrees to notify if the rental will be extended or if hirer cannot deliver at the / or before the appointed time. If the car is delivered too late, the lessor is in his right to apply another day of rent to the rental agreement. This does not give the hirer the right to rent the car a new day. This must be approved by the lessor.
17. The hirer or Cardholder shall grant the lessor the authority to make credit card instructions for debits for, for example, the market value of the vehicle if it's not returned to us, all toll fees, penalties, damage, towing, legal costs, loss or administrative fees imposed on and incurred by the lessor for, parking violations, traffic violations and other violations which the hirer has caused to the lessor to incur and make payments of fees in accordance with what the lessor regards as necessary.
18. The hirer and / or the cardholder's signature below shall apply as confirmation of the credit card instructions and shall give the lessor the authority to debit your credit card accordance with above authority. This right to debit the credit card shall also apply to any agreed extension of the term of the hire agreement and other expenses the lessor can get after the rental due to the hirer.
19. Processing of personal data. The hirer and any other drivers' personal data are processed in accordance with the lessor's personal privacy data that is available on the lessor's website or made available otherwise. The hirer is obliged to inform any other drivers on the processing of personal data.

I/we hereby declare that the vehicle has been hired for the term and on the conditions stipulated in the present agreement and hereby sign for the vehicle received. The undersigned Hirer/cardholder shall be personally liable for the conditions stipulated in the above, including contractual payment of the rent.
